



## Hik-Connect Setup

- Connect your mobile device to Wi-Fi.
- Download and install the Hik-Connect app by searching the "Hik-Connect" in App Store or Google Play™. If you want to use AP function, download Hik-Connect 3.10.0 or above.

## Add the Camera to Your Hik-Connect Account

- Start the adding process only when the indicator flashes
- Connect your mobile phone to a Wi-Fi (5G Wi-Fi is not supported yet).
- Log into the Hik-Connect app.
- In the Home page, tap "+" on the upper-right corner to add a camera.
- Scan the OR code on the bottom of the camera or on the Quick Start Guide cover.
- Follow the prompts to set the network connection and add the camera to your Hik-Connect account, (Locate the camera within 3 meters from the router when setting up the Wi-Fi.)

### Recording

- Check the memory card status by tapping on the Storage Status in the Device Settings interface.
- If the memory card status displays as Uninitialized, tap to initialize it. The status will then change to Normal. You can then start recording any event-triggered video in the camera such as motion detection.
